Crestfield Camp & Conference Center is located near Slippery Rock just 50 miles north of Pittsburgh.

### **From Route 79 North**

- Take Exit 105 and make a left onto Route 108 East.
- Go 6/10 of a mile and make a right turn on West Park Road (by the closed Dairy Queen).
- You will cross a creek and there is a campground on the right. Travel 1 mile on this road, and then make a left turn onto Kelly Road (which is at a 4-way intersection with no stop).
- After 1 mile, you will come to a stop sign. Continue to go straight for another mile.
- At the stop sign, make a sharp right onto Taggart Road. Crestfield is on the left, at the top of the hill.
