A Mission Fair will precede the September meeting. With prior approval, presbytery-related groups may set up a Mission Fair table or booth to display materials and have someone on hand to interpret them before the meeting. **YOU MUST CONTACT** the Stated Clerk's Office to reserve Mission Fair table/display space (412-697-9207); let us know when the reservation is made if a display requires an electrical outlet. For this meeting, **please contact the Stated Clerk's Office not later than September 18, 2017.**

**Two** communications are issued for meetings of Pittsburgh Presbytery:

The **first** communication, this Notice of Meeting and Docket, is emailed not later than the tenth working day before each meeting to each commuter minister member of presbytery, to each enrolled elder commissioner, and to each church and Clerk of Session. Clerks of Session must forward these documents to the church's elected elder commissioners. The Notice and Docket will be mailed to those individuals and churches who have informed the office of the Stated Clerk that they do not have access to the presbytery's website. **The meeting notice and docket are sent from the presbytery via Constant Contact. Those who do not receive emails from Constant Contact must check the presbytery website or contact the office of the Stated Clerk to obtain a copy.**

The **second** communication is when meeting business materials are posted on the Pittsburgh Presbytery website, [www.pghpresbytery.org](http://www.pghpresbytery.org), no later than five business days before each meeting. Each minister member and each elder commissioner is responsible to download the meeting business materials from the presbytery's website and to bring those materials with them to the meeting. Business materials are mailed to those individuals and churches who have informed the office of the Stated Clerk that they do not have access to the presbytery's website. [Occasionally, last-minute meeting business materials may also be printed and distributed before the meeting at a publications table.] A very limited number of meeting business materials packets will be available at each meeting from the Stated Clerk.
